This market will resolve to "No" if any of the following conditions are met between December 1, 2025, 12:00 AM ET and December 31, 2025, 11:59 PM ET:

- Epstein client list released
- Russia x Ukraine ceasefire
- US x Venezuela military engagement
- Putin meets with Zelenskyy
- Bitcoin reaches \$120,000

Otherwise, this market will resolve to "Yes".

## 1. Epstein client list released

This market will resolve to "No" if files which were not previously public and which pertain to the illegal activities of Jeffrey Epstein are made public during this market's above-specified time frame, and those files contain a list of individuals associated with Epstein in connection with his illegal activities, including but not limited to sex trafficking or related crimes.

To qualify, the files must contain names in a context equivalent to what is commonly referred to as Epstein's "client list"—that is, a document that explicitly identifies a list or set of individuals as being directly connected to, participating in, facilitating, funding, soliciting, or otherwise being implicated in Jeffrey Epstein's illegal activities.

A document may qualify even if it does not contain explicit incriminating language on its face, so long as credible reporting or accompanying official context confirms that the released document is an incriminating client list or functionally equivalent roster of individuals tied to Epstein's illegal activity.

The following will not qualify:

- Flight logs, passenger manifests, visitor logs, or transportation records which merely show individuals traveling with, meeting with, or visiting Epstein without any explicit or contextual tie to criminal activity.
- Contact books, address lists, social calendars, guest lists, schedules, correspondence logs, or similar documents that include names solely due to social contact, proximity, acquaintance, or logistical interaction with Epstein.
- Any document listing individuals without accompanying language, context, or credible reporting that connects those individuals to Epstein's illegal activity.

The primary resolution sources for this market will be the released files themselves and a consensus of credible reporting.

#### 2. Russia x Ukraine ceasefire

This market will resolve to "No" if there is an official ceasefire agreement, defined as a publicly announced and mutually agreed halt in military engagement, between Russia and Ukraine during this market's above-specified time frame.

If the agreement is officially reached before the resolution date, this market will resolve to "No," regardless of whether the ceasefire officially starts afterward.

Any form of informal agreement will not be considered an official ceasefire. Humanitarian pauses will not count toward the resolution of this market.

This market's resolution will be based on official announcements from both Russia and Ukraine; however, a wide consensus of credible media reporting stating an official ceasefire agreement between Russia and Ukraine has been reached will suffice.

# 3. US x Venezuela military engagement

This market will resolve to "No" if there is a military engagement between the military forces of the United States of America and Venezuela during this market's above-specified time frame.

A "military engagement" is defined as any incident involving the use of force such as missile strikes, artillery fire, exchange of gunfire, or other forms of direct military engagement between US and Venezuelan military forces. Non-violent actions, such as warning shots or missile launches that land in territorial waters or pass through airspace, will not qualify for a "No" resolution. Intentional ship ramming that results in significant damage to (e.g., a hole in the hull) or the sinking of a military ship by another will count toward a "No" resolution; however, minor damage (scrapes, dents) will not.

Any U.S. military kinetic strike that impacts Venezuelan land territory will qualify for a "No" resolution.

Missiles or drone strikes which are intercepted will not qualify regardless of whether they land on adversarial territory or cause damage. Similarly, surface-to-air missile strikes impacting adversarial territory will not qualify for a "No" resolution (although surface to air missiles fired at an adversarial military aircraft would qualify).

Note: the U.S. Coast Guard is a branch of the U.S. Armed Forces; Venezuela's Milicia Nacional Bolivariana (militia) is a "special component" of the Venezuelan National Bolivarian Armed Forces (FANB); and Venezuela's Coast Guard (Comando de Guardacostas) is a component of the Venezuelan Navy (Armada Bolivariana) and thus part of the FANB.

The resolution source for this market will be a consensus of credible reporting.

### 4. Putin meets with Zelenskyy

This market will resolve to "No" if Vladimir Putin meets with Volodymyr Zelenskyy during this market's above-specified time frame.

An exchange of words, handshake, direct conversation, or other clear personal interaction between the named individuals will qualify as a meeting. Merely standing in proximity, making eye contact, or being present in the same room or event without direct interaction will not qualify.

A meeting is defined as any encounter where both Zelenskyy and Putin are present and interact with each other in person.

The resolution source will be a consensus of credible reporting.

#### 5. Bitcoin reaches \$120,000

This market will immediately resolve to "No" if any Binance 1 minute candle for Bitcoin (BTCUSDT) during this market's above-specified time frame has a final "High" price of \$120,000 or higher.

The resolution source for this market is Binance, specifically the BTCUSDT "High" prices available at https://www.binance.com/en/trade/BTC\_USDT, with the chart settings on "1m" for one-minute candles selected on the top bar.

Please note that the outcome of this market depends solely on the price data from the Binance BTCUSDT trading pair. Prices from other exchanges, different trading pairs, or spot markets will not be considered for the resolution of this market.
